**Sub: Update on Show Cause Notice issued by SEBI.**

**Ref: Regulation 30 of SEBI (Listing Obligation and Disclosure Requirements) Regulations, 2015.**

This is with reference to our previous disclosure dated 21<sup>st</sup> July 2023 regarding the Show Cause Notice dated 20<sup>th</sup> July 2023 (“SCN”) from Securities Exchange Board of India (SEBI) in relation to the initiation of adjudication proceedings in the matter of alleged violation of Regulation 26(6) of SEBI (Listing Obligation and disclosure requirements), 2015 (“SEBI LODR”). In this regard, SEBI *via* its order no. Order/SM/S./2023-24/28999 and letter no. EAD-10/SM/S./OW/P/34881/1/2023 dated 28<sup>th</sup> August 2023, which was received by company on 04<sup>th</sup> September 2023, has disposed off the matter on merits, by holding that the alleged violation of Regulation 26(6) of the SEBI LODR as mentioned in the SCN has not been established.
